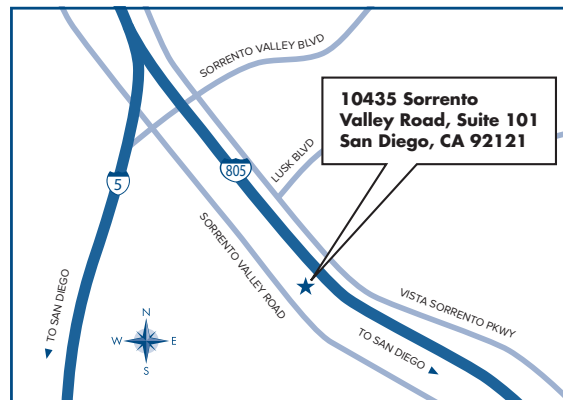


Pharmacists in Veterinary Medicine

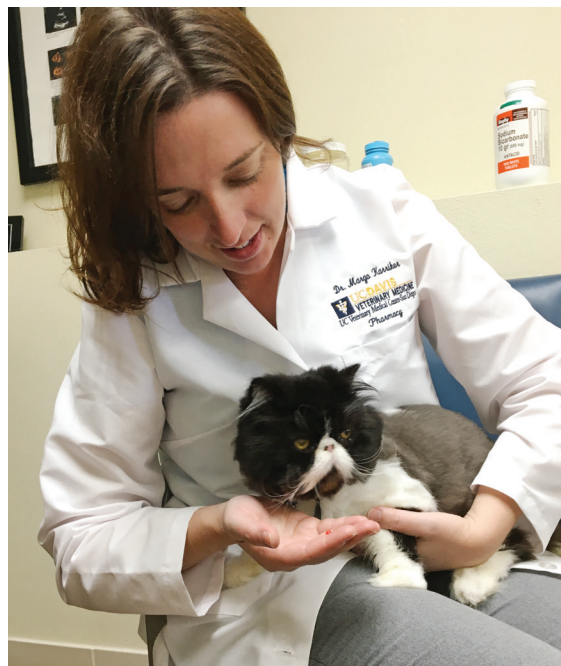

Services Available for Pet Owners:

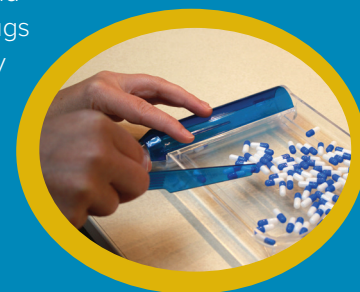
In conjunction with a primary care veterinarian, referring veterinarian or veterinary specialist, the clinical pharmacy program can offer the following services:

- General drug therapy consultations
- Product availability and drug sourcing consultations
- Drug administration advice
- Drug interaction and compatibility consultations
- Drug identification
- Medication-related news and events

Services Available for Veterinarians:

As a benefit to veterinarians, the clinical pharmacy service will offer consultations, information and services in areas such as:

- **Drug administration:**
Patient-specific information on how to administer drugs, appropriate routes of administration, dosing frequency, relative cost, comparable efficacy, and monitoring parameters
- **Drug of choice/infectious disease:**
Information on documented and alternative drug therapies for a given disease state and guidance on empiric and chronic infectious disease management
- **Drug interactions:**
Potential or probable drug-drug, drug-food, or drug-disease state interactions
- **Adverse events:**
Guidance on adverse event reporting and monitoring parameters including information on how, where and what to report
- **Laws and regulations:**
Evaluation of legal aspects of administering, dispensing and managing drugs in a veterinary practice
